The eligibility criteria prescribed is as under:

- a) Candidates holding Masters/M.Phil Degree in Statistics with a minimum post qualification experience of 4 years in the requisite field as mentioned in the details terms of Reference.
- b) Knowledge of computer applications such as SPSS, MS Word, Excel, Power Point etc.

(iii) Desirable- Good Academic Record

- a) Strong communication skills, both oral and written.
- b) Capable of data analysis and with ability to generate a well-researched with written report.
- c) Experience in collection, compilation and analysis of data.
- d) Candidates having additional qualifications, research experience published papers in the relevant field would be preferred.
- (iv)Period of Engagement: Research Associatesselected will be appointed on contract basis for an initial period of one year. This term can be extended up to a maximum of three years depending on the performance of the candidate/need of the NBA. However, the maximum duration of the contract will not be extended beyond three years.
- (v) Age Limit: Themaximum age limit for Young Professionals shall be 40 years.
