2. Therefore vouchers for performing to and fro journey through Auto fare were enclosed.

Also, 60 applications have been received in case of Director, NITTTR Chandigarh and is being tabulated.
 - ii. The budgetary matter of 4 NITTTRs. In which, staff of TS.IV Section was frequently visiting North Block, UGC, AICTE etc on day to day basis.
 - iii. Dealt 10 parliament unstarred question in the ongoing Monsoon session -2021.
 - iv. Matter related to Deemed to be University status.
 - v. 4 NITTTRs Annual Reports 2020-21 - In which, staff of TS.IV Section was frequently visiting camp office of MoS & parliament for its early approval.
 - vi. The implementation of NINTTT and NIMT schemes under New Education Policy, 2020 for teacher training in technical and non-technical Institutes.
