



Sub: 1st Appeal against the reply of the CPIO (F. No. NBA/RTI/2022/006/3201 dt. 08/04/2022, received by the applicant on 16.4.2022)

Sir,

I had submitted one RTI application dated 22nd March 2022, received in NBA on 25/03/2022. I had sought for information related to three points.

I have received one reply of the CPIO, mentioned supra, and denying the information sought. In this regard, being dissatisfied, I would like to submit the first appeal to you with the following.

- 1. The information that I have requested doesn't come under the exempted category where disclosure is barred in the RTI act.
- 2. The CPIO has not cited any sub-section of sec. 8 & sec. 9 of the RTI act in his reply for denying the information.
 - Central Information Commission in Mr. Harpreet singh vs CPIO & Chief Manager - HR(M) ITI Limited, File No. CIC/BS/A/2013/000681/4968, dated 24 April 2014, held that, "Access to information, under Section 3 of the Act, is the rule and exemptions the exception. The information can be denied only if it is exempt as per the provisions of Section 8 or Section 9 of the RTI Act. Further, while denying information the authority withholding the information must show satisfactory reason and such reason should be germane and based on some material. Sans this consideration the information cannot be denied."
 - Also in Appeal: No. CIC/OK/A/2006/0016, Dated, the 7th July, 2006, CIC held, "Through this Order the Commission now wants to send the message loud and clear that quoting provisions of Section 8 of the RTI Act ad libitum to deny the information requested for, by CPIOs/Appellate Authorities without giving any justification or grounds as to how these provisions are applicable is simply unacceptable and clearly amounts to malafide denial of legitimate information attracting penalties under section 20(1) of the Act."
- 3. From the perusal of the CPIO's reply, it is understood that the Expert Team of the NBA has already visited the university during 11-13th March 2022.
- 4. The SAR (point no. 1) is normally uploaded by the respective institutes in their websites. However, I have failed to find out one in Maulana Abul Kalam Azad University of Technology's website, hence the RTI application.

- 5. It is not clear how providing the information that was sought in point 1 and 2 come under any exemption sections of the RTI act.
- 6. Also the RTI act has overriding effect according to sec. 22 of the act.

Thus, I would like to request you to instruct the CPIO to provide point wise information to my queries. Also, regarding CPIO's comment on point 2 of the application, I would like to request to provide the attested copy of,

Any communication between the NBA and the university regarding the faculty (teacher) details of the IT department of the said university,

And

Any form/ report/ annexure or equivalent that is available with NBA which were sent / uploaded to the portal by the university containing the details of their faculty/ teachers of IT department.

Anticipating kind cooperation from you're your end u/s 5(3) of the RTI act. Considering the volume of information, I had already paid additional charges through IPOs towards the cost of documents along with the RTI application.
