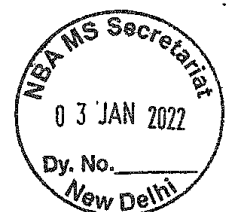

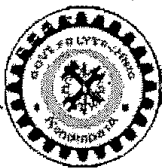

Sub Clarification on Contractual Faculty for NBA Accreditation

Sir/Madam,

With reference to the above subject and discussion held in the review meeting of some of the Principals of Govt. Polytechnics on 31/8/2021, I am to say that doubt has been raised in the institutions as to whether the Guest faculties engaged in Govt. Polytechnics can be treated as Contractual Faculty for the purpose of applying for NBA Accreditation or not.

The norms and definition of NBA over Contractual Faculty in their Pre-Qualifier format specifies that, a teacher who is not a Regular Faculty can be termed as Contractual Faculty if, he/she

(i) has taught for two consecutive semesters in the corresponding academic year on Full time basis

(ii) shall have AICTE prescribed qualification and experience

(iii) should have gone through appropriate selection process.

As is understood, the present practice followed in Govt. Polytechnics is that, Guest faculties are engaged on open selection from the AICTE qualified persons through News paper advertisement once in a year. The engagement is mostly for the entire year (2 consecutive semesters) and are allotted with teaching load as per AICTE norms. Thus the present form of engagement of the Guest faculties satisfy all the 3 criteria specified by NBA for calculation of contractual faculty and hence can be termed as Contractual faculty for applying for NBA Accreditation.

In case, any Guest faculty does not satisfy the criteria of Full teaching load as per AICTE norms or duration of his/her engagement is not for 2 consecutive semesters in any academic
