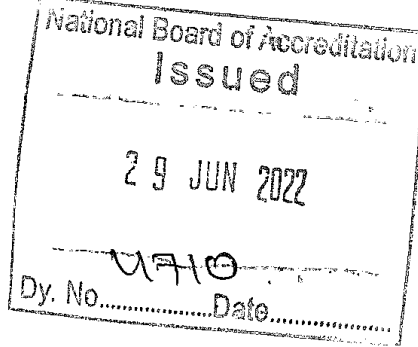

One KPRIT (Kommuri Pratap Reddy Institute of Technology, College Address:-Sy No 1140, Near Infosys, Adjacent to NTPC Power Grid, Ghanpur Village, Ghatkesar(M), Malkajigiri Dist., TS 500 088) running the Institute without any QUALITY GRADUATES since PROFIT is the ONLY MOTTO without adhering to the guidelines issued by either UGC or JNTU but apparently they are showing on paper which are supposed to be strictly followed.

The guidelines is to be followed to accord permission for the accreditation may be given to me. This is the request under the RTI ACT.

Further glaring irregularities committed by KPRIT (Kommuri Pratap Reddy Institute of Technology) are hereby enumerated.

1. STUDENT – TEACHER RATIO.
2. SALARIES TO BE PAID THROUGH CHEQUE .
3. QUALIFIED FACULTY MEMBERS IF THERE ARE ANY, BEING PAID ONLY Rs.30000.00 PER MONTH, WHEREAS UNDER THE UGC GUIDELINES A MINIMUM OF Rs.100000.00 OR THE LAST SALARY WHILE GETTING RETIRED.
4. ADMITTEDLY THEY ARE SHOWING FACULTY MEMBERS ACCORDING TO THE GUIDELINES ON THE DAY OF INSPECTION, BUT IT IS SURPRISING TO KNOW AFTER ONE WEEK EVERYBODY WHO WERE SHOWN ARE NOT FOUND IN REGULAR FACULTY. DESPITE OF BIOMETRY NOBODY IS VERIFYING THE VERACITY OF THE FACT.
5. THOUGH ADMITTEDLY THEY GIVE NOTIFICATION FOR THE REQUIREMENT FOR THE FACULTY BUT THE TIME LIMIT TO WHICH ADHERED TO IS NOT NOTIFIED, SINCE IT IS ONLY AN ALIBI TO SHOW THE AUTHORITIES. IT IS ADMITTED BY THE PRESENT PRINCIPAL.
6. THERE IS ONLY QUANTITY IS EMERGING FROM THE ENGINEERING COLLEGES WITHOUT ANY QUALITY TO COMPETE WITH THE REST OF THE WORLD.
7. THERE IS NO REMITTANCE OF PROVIDENT FUND.
8. 10% OF THE SALARY IS PAID THROUGH CASH, WHEREAS IT IS MANDATORY TO PAY THROUGH CHEQUE.
9. THE AUDIT REPORT SUBMITTED TO THE AUTHORITIES ARE FULL OF FABRICATED FACTS.

These are the suggestions which may be looked while granting accreditation to the ALL THE ENGINEERING INSTITUTIONS.

I am herewith appending a POSTAL ORDER of Rs.10.00 to obtain requisite information.

Therefore I kindly request you to look into the matter and do the needful as per the RTI ACT.
