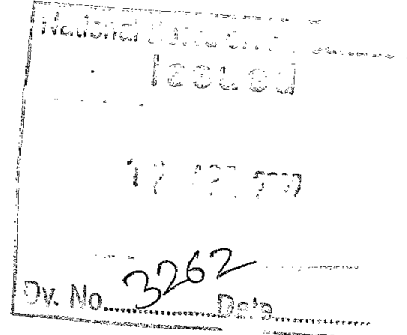

The Student Faculty Ratio(SFR) in respect of UG programs was revised by the AICTE from the Academic Year 2018-19 to 20 : 1. Accordingly, NBA also changed the SFR pertaining to UG programs as 20 : 1. However, as per evaluation guidelines followed by NBA, the norms for SFR are followed by giving marks proportionally from a maximum of 20 to a minimum of 10 for average SFR between 15 : 1 to 25 : 1 and zero for average SFR higher than 25 : 1.

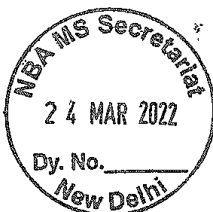
